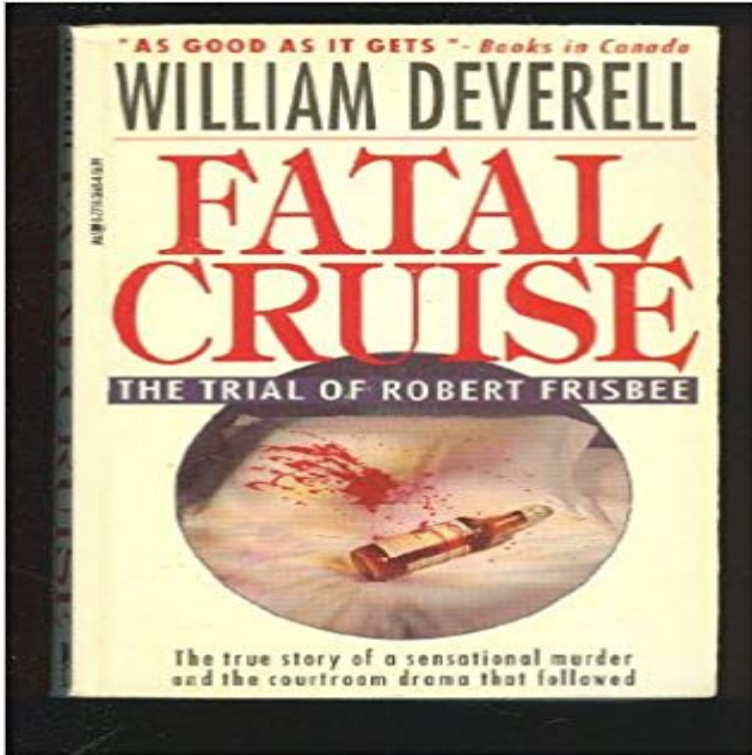


# Fatal Cruise: The Trial of Robert Frisbee
