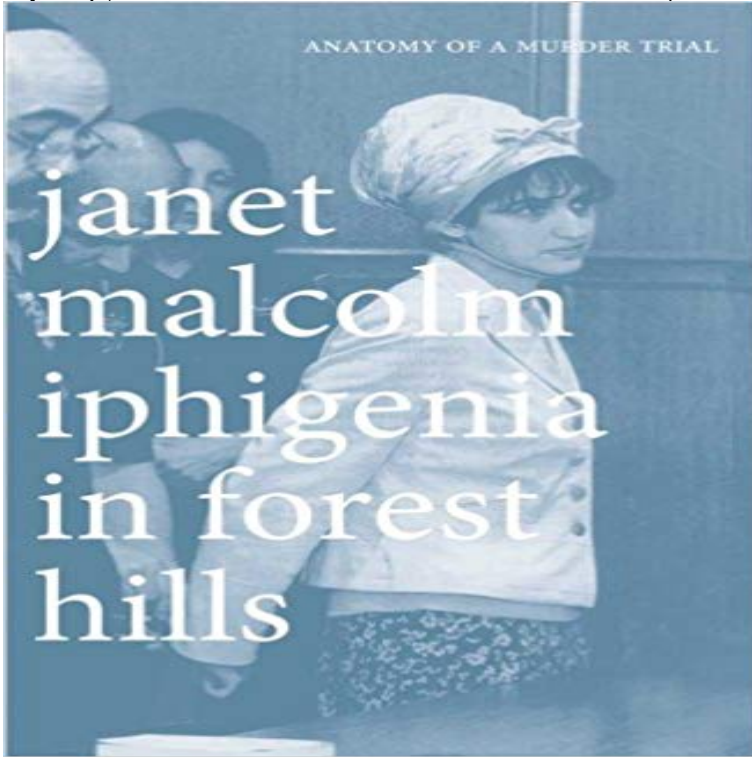


Iphigenia in Forest Hills: Anatomy of a Murder Trial
